An election is not required if the adopted tax rate is less than or equal to the voter-approval tax rate.

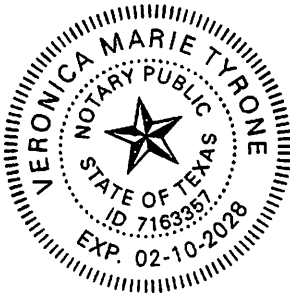
